

CPP40707 Certificate IV in Security and Risk Management

COURSE OVERVIEW

- This qualification is suited to individuals who are responsible for security and risk management. This qualification reflects the role of individuals who use well-developed skills to evaluate security vulnerability and risk, as well as develop security counter measures for their organisation or clients.
- The course is best suited to those who are employed and working in the security industry and are ready to advance and take on roles at the middle management level or who wish to work as an independent security consultant and contractor. The qualification is the one of the most sought after nationally recognised qualifications within the security industry.
- The course is a mandatory requirement for those who wish to obtain their NSW Class 2A (Security Consultants) Licence.

COURSE ENTRY REQUIREMENTS

- There are no pre-requisite entry requirements for these programs; however we would expect you already work in the security industry and at a minimum hold a NSW Class 1AC Licence, although these are not mandatory for this course. We would also expect that you exhibit a strong sense of leadership and focus, as this course ideally suits those who are serious about progressing and maintaining a career in the security industry.
- You must be at least 18 years of age and you must complete a Language, Literacy and Numeracy Test aligned to the Australian Core Skills Framework.
- Neat and tidy attire must be worn each day including enclosed footwear at all times if the program is conducted face to face.
- You must have access to the internet and a computer to conduct self paced study and research away from the classroom.
- You will also need to provide one piece of valid Photo Identification, preferably your NSW Class 1AC Licence, Passport or Drivers Licence.

DURATION & STRUCTURE

Typically this program is run as distance education, with self paced research and analysis. Learners must complete a total volume of 600 hours of learning and have up to 12 months to submit all assessment.

Learning materials and resources will be provided electronically through the student learning portal on our website and students will have access to their trainer via the portal.

Assessment is a combination of written answer, case study and scenario based analysis. Applicants may also apply to be assessed through Reginition of Prior Learning if they are working in the security industry or a related environment.

Learners who have difficulty completing in the allocated time period will be given extra tuition and all learners have up to the 12 months to complete.
